Environmental Impact of Cig Butts

- 4.95 trillion cigarette butts are disposed of in our environment annually
- Cigarette butts leach toxins when wet, posing a threat to marine and wildlife
- Cigarette butts can take up to 25 years to decompose
- Cigarette butts pose a significant fire threat
- Litter clean-up costs the U.S. over 11 billion annually

Ashcans reduce cigarette butt litter and improve the quality of business districts for residents and visitors. The ashcans are affixed above the ground in high foot-traffic locations. These durable outdoor receptacles provide measureable results of cleaner and healthier surroundings and environment.
